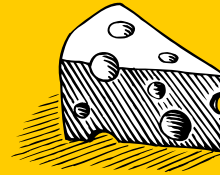
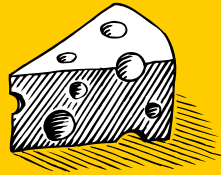

 - 23% - would not like to see more weekend rides

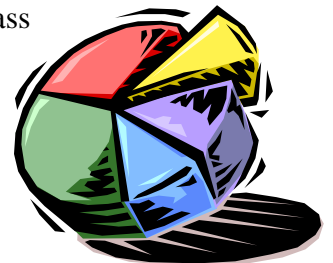
