




Meeting Changes!

Starting in January, the meeting night and location is changing.

Safety Officer Corner

Recently, the National Transportation Safety Board (NTSB) is calling on all States that do not have a mandatory helmet law to adopt one. The NTSB has no regulatory ability and no law making ability, just the power to issue recommendations to the States, industry and the Federal government. Regardless, there are those with an agenda of protecting us from ourselves will jump on this recommendation and try to forge a helmet law. It will be up to us as motorcyclists to stand against any attempt to curtail our freedom as pertains to this aspect of our lives. This is not about motorcycle safety, rather it is about whether we will allow our government to tell us how we must attire ourselves to use our motorcycles. Proponents will doubtlessly try to convince people that the health care law requires this regulation because everyone will bear the financial burden of a paralyzed bikers health care. The truth is that it will be just one more freedom taken from us if we let them. In our HOG we have both types of preferences, I prefer to wear a helmet while others prefer not to. I don't believe it is up to anyone in our group to tell any other member that they must wear a helmet, nor would it be right for Harley Davidson to force that rule upon us. It would be just as wrong for the government to do so.

As of Friday, 11/20/2010 the motorcycle rider fatality numbers for Wisconsin were 98; this is about a 13 percent increase over 2009 and a tragic and discouraging statistic. In 2009, 84 riders were killed and although unacceptable, it was an improvement over the previous year . Passenger deaths this year were at 7, a reduction of one person over 2009.

I believe the NTSB falls short of the mark when recommending mandatory helmet usage. The best recommendation would be for mandatory motorcycle safety courses for any person who does not have the endorsement but who wants to become a motorcyclist. When required before being allowed to practice ride it would represent the opportunity to choose to accept the regulations. This should be followed by a period of daytime only riding and finally a test for license. Ahh! but you say that's more government intrusion. A license to use a motor vehicle on our highways is a privilege, not a right and the best way to insure a motorcyclists safety is to give them the tools to make the best decisions when riding a motorcycle. For some people that would include wearing a helmet

Not everyone will agree with my idea, but it may be time to start looking for solutions that everyone can live with as opposed to solutions that stifle our rights.
