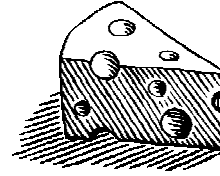
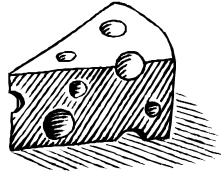

## HOG Minutes – 12/10/13

Pledge led by John Deackman.

Wendy Holmes gave updates on food options for the Holiday party. Barb Newcomer quoted \$13-15 for 2 meats, potato, 3 salads, veggie and 2 kinds of bars. Tax and tip not included. Wendy would need to pick up the food.

Laughing Trout quoted \$16.88 for chicken marsala, sirloin steak, Gouda mashed potatoes, Green beans, and tossed salad. Tax and tip not included. They would deliver and pick up. Wendy suggested going with Barb as she donated some goods for the Cannon Ball run this summer. Chapter voted-will go with Barb Newcomer. Deb motioned for the chapter to pay for Wendy's meal for her efforts and for her having to go pick up the food. Chapter voted-will pay for Wendy's meal.

John suggested the chapter pay for the whole cost of everyone's meal that attends the party. Everyone would donate towards the tip if needed. Curt Moyer suggested that we go with 50/50 like we have previously so that those members that are unable to make it to the party are not left out of a benefit. Chapter voted-passed 50/50.

Chapter voted on the food options:
